#### I. Welcome

Dr. CHUI Yat Hung, the President of the HKPCA, extended a warm welcome to all members for joining the  $20^{\text{th}}$  Annual General Meeting.

# II. Confirmation of the 19<sup>th</sup> AGM Minutes

The minutes of the 19<sup>th</sup> AGM was confirmed and distributed with Mr. Jeffrey Ip being the proposer and Dr. Chui Yat Hung as the seconder.

#### III. Annual Report 2014-2015 presented by the President

The president reported that the HKPCA Council managed to hold **6** meetings from Sept 2014 to June 2015 (112<sup>th</sup>- 117<sup>th</sup>). HKPCA strived to continue following the association's vision of promoting professional standard and developing continuous professional development for counsellors. We have accomplished some major tasks and were happy to have accomplished most targeted tasks. We were happy to have experienced members for serving the Council and Sub-Committees in this year.

# <u>Initiatives and major decisions were summarized from confirmed minutes of</u> our Council meetings and were shown as follows:

- 1. So far a total of 8 master degree programs offered by 7 tertiary institutions in Hong Kong have been accredited. Among them, 6 programs offered by 5 institutions recently passed the three-year review (HKU, CUHK, PolyU, CityU, BU) with 1 program (Bethel Bible Seminary) undergo its final review in September. Vice President Dr. Annis Fung has further elaborated the background and latest progress report.
- 2. In order to further promote the counselling development in Hong Kong, a Professional Development/ Research committee will soon be formed to perform researches on related issues.
- 3. The President has reported an increase of general membership of :

General Membership +2% Professional Membership +14% Approved Counseling Supervisor +27%

There is a 2% increase of membership from 772 to 788 in 2014-2015 in various categories. Total membership accumulated since 2011 to end July 2015 was 1179. Certified Counsellor has increased by 14% from 78 counsellors in 2013-14 to 89 counsellors in 2014-2015. Approved Supervisor has increased by 27% from 67 supervisors in 2012-13 to 85 supervisors in 2014-2015. (Dr. TAM Chung Ngok Isaac further elaborated on site the reason and anticipated challenge ahead, details refers to Appendix 1).

- 4. To expand our membership to those with substantial counselling experience and training at diploma level, a new membership category 'Associate Member' was established. HKPCA did not have Associate Member approved by end 2014 yet.
- 5. To enhance counselling professionalism, the Council proposed to require all local applicants for Certified Counsellor to be graduates from a HKPCA accredited local master program. The minimum academic level for professional membership in HKPCA should be <u>a HKPCA</u> accredited master's degree in counselling. Other master's degree in counselling or its equivalent <u>will</u> be <u>assessed</u> on a case by case basis. This would further confirmed in the Annual General Meeting.



- 6. HKPCA published two newsletters in December 2013 and July 2014. We target to release Newsletter in Oct 2015, Feb and June in 2016 and publish in our official website. Contents of October issue include "本地輔導工作專業化", Upcoming Programmes and Workshops. Association's official website is also revamped. A working group led by Dr. WU Ka Yu Florence would follow up the change.
- 7. A special word of thanks goes to our honorary legal advisor Mr. YU Kim Fung (Leung & Co, Johnny K.K.) and Louis Leung & Partners CPA Ltd as our honorary auditor who continued to support HKPCA in the past year .We appreciate their time and effort even more. They both will be reappointed for the coming year 2015, proposed by Dr. Chui Yat Hung and seconded by Mrs. CHAN Cheung Choi Wan Vivien.

# IV. Financial Report provided by Treasurer, Mrs. CHAN Cheung Choi Wan, Vivien

Mrs. CHAN CHEUNG Choi Wan Vivien, Treasurer, presented the Financial Report 2014. The Association's Honorary Auditor, Louis Leung & Partners CPA Limited, audited the financial statements and concluded that the statements gave a true and fair view of the financial status of the HKPCA as at 31 December 2014. A tiny deficit of \$1,804 was recorded. The Financial Report 2014 was proposed to be adopted by Mrs. CHAN CHEUNG Choi Wan Vivien, and seconded by Dr. Chui Yat Hung.

V. Council Election 2014-2015- completed.

# VI. The Program committee has worked out the following workshops objectives and reported workshop activities as follow:

- To advise and make recommendation to the HKPCA on matters concerning professional development programmes for members/non-members;
- To reflect to HKPCA the problems encountered in programme implementation and make suggestions for improvement;
- To co-opt additional members may be required;

In the past year, the Association has offered **7** different professional trainings to our members. A total amount of *HK\$* 120,126 has been generated to the Association's income. Details were shown in Appendix 2. The Association has planned to offer different nature and level of programmes to members in the coming year, such as:

- •Emotional Focused Therapy
- •Couple Therapy
- Narrative Therapy

#### VII. Endorsement of new Fellows:

2 new Fellows were endorsed and listed as follows;

The endorsements of new Fellows was proposed and elected in June Council meeting.

VIII. **8 Motions** presented by Chair, Membership & Professional Standards Committee, Dr. TAM Chung Ngok Isaac.

#### **Motion 1**

That the ratio between post-graduation Supervised Practice Hours and post-graduation Supervision Hours be *at least* FOUR & A HALF to ONE (4.5:1), which means for every 4.5 practice hours, there should be at least 1 supervision hour.

[Background: This is a refined specification for certification candidates to follow and is consistent with the overall 450: 100 practice requirement.]

This motion will be further discussed in Sept council meeting.

#### **Motion 2**

That in post-graduation group supervision, the *maximum* number of supervisees allowed in one supervision group be SIX (6).

[Background: For better quality, this is another refinement for certification candidates to follow by specifying clearly the group size in group supervision.]

#### **Motion 3**

That in the practicum component of an Accredited Counselling Programme, the number of Supervised Practice Hours be *at least* FIFTY (50).

[Background: The current requirement is only that such a programme should have a practicum component without specifying the number of hours. Clear specification is required to maintain the quality of an accredited counselling programme.]

#### **Motion 4**

That in the practicum component of an Accredited Counselling Programme, the ratio between Supervised Practice Hours and Supervision Hours be *at least* THREE to ONE (3:1), which means for every 3 practice hours, there should be at least 1 supervision hour.

[Background: As most programmes can only realistically provide much fewer than 300 supervised practice hours, it is important to require more supervision hours for a trainee before graduation.]

#### Motion 5

That in the practicum component of an Accredited Counselling Programme, the *maximum* number of supervisees allowed in one supervision group be SIX (6).

[Background: Refinement for quality enhancement consistent with post-graduation group size requirement for certification candidates.]

#### **Motion 6**

That in the practicum component of an Accredited Counselling Programme, Individual Supervision be a face-to-face supervision for ONE supervisee, and appropriate observers be allowed.

[Background: Emphasis on face-to-face individual supervision, with allowance for the presence of observers as commonly conducted in marriage and family counselling supervision.]

#### **Motion 7**

That in the practicum component of an Accredited Counselling Programme, the ratio between Total Supervision Hours and Individual Supervision Hours be *at least* SIX to ONE (6: 1), which means for every 6 supervision hours, there should at least be 1 individual supervision hour.

[Background: To enhance quality, the minimum requirement for individual supervision hours is clearly spelled out.]

All the above motions become **retroactively effective 1 January 2015**, so such improved requirements could cover the counselling programs reviewed since January 2015. This can then properly acknowledge the contributions of the Program Accreditation Subcommittee which has worked very hard with numerous meetings to elevate the quality of our accredited programs in the recent round of 3-year reviews.

#### **Motion 8**

That Certification Requirement 2 be revised as follows (changes underlined and italicized, with the removal of the asterisked and italicized statement):

#### Requirement 2:

The minimum academic level for professional membership in HKPCA should be <u>a HKPCA</u> accredited master's degree in counselling. Other master's degree in counselling or its equivalent <u>will</u> be <u>assessed</u> on a case by case basis.

\*Amendment of Academic Requirement:

All local Hong Kong applicants for Certified Counsellor must be graduates from a HKPCA accredited local master program and this requirement is effective from 1 January 2015. (Approved in 2014 AGM)

[Background: our Fellow Dr. YUEN Man Tak has recently pointed out that this statement is discriminatory. Remarks by some committee members have also pointed to the need to modify this statement. Removal of the statement is much better because the original statement is already clear enough for our operation and vetting.]
