Handling crisis is an important topic in youth work as inappropriate handling may result in pain, suffering, fear and sometimes loss of life amongst our clients. For example in school settings, school teachers in Hong Kong are faced with a seemingly unending escalation of workload. More effort should be spent on assisting professional working with youth to handle crisis in their work.

In these 2 case conferences, emphasis is put on concepts of crisis and intervention. Participants are requested to bring along case example for discussion and practical applications.
